**SECTION 4. First aid measures****4.1. Description of first aid measures**

No effects requiring implementation of special first aid measures are expected. The following information represents practical indications of correct behaviour in the event of contact with a chemical product, even if not hazardous.

Use jets of water to cool the containers to prevent product decomposition and the development of substances potentially hazardous for health. Always wear full fire prevention gear. **SECTION 7. Handling and storage****7.1. Precautions for safe handling**

Keep away from heat, sparks and naked flames; do not smoke or use matches or lighters. When performing transfer operations involving large containers, connect to an earthing system and wear antistatic footwear. In order to avoid the risk of fires and explosions, never use compressed air when handling. Open containers with caution as they may be pressurised. Do not eat, drink or smoke during use. Avoid leakage of the product into the environment.
