# **SECTION 4. First aid measures**

#### 4.1. Description of first aid measures

No effects requiring implementation of special first aid measures are expected. The following information represents practical indications of correct behaviour in the event of contact with a chemical product, even if not hazardous.

#### 6.1. Personal precautions, protective equipment and emergency procedures

If there are no contraindications, spray powder with water to prevent the formation of dust.

# 7.1. Precautions for safe handling

Keep away from heat, sparks and naked flames; do not smoke or use matches or lighters. When performing transfer operations involving large containers, connect to an earthing system and wear antistatic footwear.
